This Privacy Policy sets out our commitment to protecting the privacy of personal information provided to us, or otherwise collected by us, offline or online, including through our website (Site).

In this Privacy Policy **we, us or our** means San Lorenzo Restaurant, ABN 28635495144.

1. Personal information

The types of personal information we may collect about you include:

- your name
 - your contact details, including email address, mailing address, street address and/or telephone number
 - your age and/or date of birth
 - your credit card or payment details (through our third party payment processor)
 - information you provide to us through customer surveys
 - your browser session and geo-location data, device and network information, statistics on page views and sessions, acquisition sources, search queries and/or browsing behaviour
 - information about your access and use of our Site, including through the use of Internet cookies, your communications with our Site, the type of browser

you are using, the type of operating system you are using and the domain name of your Internet service provider

- additional personal information that you provide to us, directly or indirectly, through your use of our Site, associated applications, associated social media platforms and/or accounts from which you permit us to collect information
- any other personal information requested by us and/or provided by you or a third party

2. Personally identifiable information

This privacy policy deals with personally identifiable information (referred to as “data” below) that may be collected by this site. This policy does not apply to other entities that are not owned or controlled by San Lorenzo Restaurant, nor does it apply to persons that are employees or agents of San Lorenzo Restaurant, or that are not under the Site editor’s control.

3. Collection of data & use
